



Appendix to the Memorandum of Understanding Agreement for Student Exchange between National Tsing Hua University, Taiwan

University of Science-Vietnam National University, Ho Chi Minh, Vietnam

This Agreement is an appendix to the Memorandum of Understanding between:

National Tsing Hua University (hereinafter referred to as "NTHU"), an institution of higher education headquartered at No. 101, Section 2, Kuang Fu Road, Hsinchu 30013, Taiwan,

and

University of Science-Vietnam National University, Ho Chi Minh (hereinafter referred to as "VNUHCM-US"), an institution of higher education headquartered at 227 Nguyen Van Cu Street, District 5, Hochiminh City, 700000, Vietnam.

Both institutions have approved the student exchange program as follows:

1. Duration of Stay

Duration of stay of exchange students at the host institution shall be one semester or one academic year.

2. Numbers of Exchange Students

Each institution may send and accept not more than two (2) students each academic year. Two students for one semester each would be equal to one student for two semesters in a given year.

3. Status of Exchange Students

Each institution shall accept exchange students to the host institution as full-time students who do not aim at obtaining a degree in the host institution.

4. Recommendation and Acceptance of Exchange Student Candidates

The home institution shall select candidates on the basis of faculty nomination for the exchange program and shall recommend candidates to the host institution; however the final determination of acceptance of candidates shall be at the sole discretion of the host institution. The field of specialization of the exchange student shall depend on the availability of an advisor or supervising professor at the host institution.

5. Study Program and Evaluation

Each student shall determine the study program at the host institution in consultation with academic advisors of both home and host institutions if needed. The academic performance shall be evaluated according to the rules of the host institution.

6. Academic Record and Accreditation

The host institution shall transmit the academic record of each exchange student to the home institution and credits will be conferred according to the regulations of the home institution.

7. Tuition Fees

Exchange students are exempted from paying the tuition fees to the host institution.

8. Financial Responsibility

Exchange students shall be responsible for their own personal expenses such as travel expenses, accommodation, living costs, health care fees and insurance, student union fees, computer and internet fees. All students shall be required to become members of such health care insurance scheme as the host institution recommends.

9. Term of Validity

This agreement shall remain in force for a period of five (5) years from the date that it is signed by both institutions. This agreement, with the written consent of both institutions, may be extended or terminated, with a six (6) months' period of notice, by either institution. In case of termination, the commitments made to students already participating in the programs must not be affected.

10. General

10.1 CONFIDENTIALITY

If this exchange should involve any confidential information or materials, a separate Non-disclosure agreement will be required.

10.2 Administrative Expenses

NTHU and VNUHCM-US shall be responsible for their own administrative expenses respectively.

10.3 Resolution of Conflict and Disputes

In the event of any dispute arising out of or in connection with this memorandum, both Universities agree to resolve the matter in good faith.
